Russian outrage following the September 2004 hostage disaster at North Ossetia's Beslan Middle School No.1 was reflected in many ways throughout the country. The 52-hour debacle resulted in the death of some 344 civilians, including more than 170 children, in addition to unprecedented losses of elite Russian security forces and the dispatch of most Chechen/allied hostage-takers themselves. It quickly became clear, as well, that Russian authorities had been less than candid about the number of hostages held and the extent to which they were prepared to deal with the situation. Amid grief, calls for retaliation, and demands for reform, one of the more telling reactions in terms of

hardening public perspectives appeared in a national poll taken several days after the event. Some 54% of citizens polled specifically judged the Russian security forces and the police to be corrupt and thus complicit in the failure to deal adequately with terrorism, while 44% thought that no lessons for the future would be learned from the tragedy. This pessimism was the consequence not just of the Beslan terrorism, but the accumulation of years of often spectacular failures by Russian special operations forces (SOF, in the apt US military acronym). A series of Russian SOF counterterrorism mishaps, misjudgments, and failures in the 1990s and continuing to the present have made the Kremlin's special operations establishment in 2005 appear much like Russia's old Mir space station—wired together, unpredictable, and subject to sudden, startling failures. But Russia continued to maintain and expand a large, variegated special operations establishment which had borne the brunt of combat actions in Afghanistan, Chechnya, and other trouble spots, and was expected to serve as the nation's principal shield against terrorism in all its forms. Known since Soviet days for tough personnel, personal bravery, demanding training, and a certain rough or brutal competence that not infrequently violated international human rights norms, it was supposed that Russian special operations forces—steeped in their world of “threats to the state” and associated with once-dreaded military and

national intelligence services—could make valuable contributions to countering terrorism. The now widely perceived link between “corrupt” special forces on the one hand, and counterterrorism failures on the other, reflected the further erosion of Russia’s national security infrastructure in the eyes of both Russian citizens and international observers. There have been other, more ambiguous, but equally unsettling dimensions of Russian SOF activity as well, that have strong internal and external political aspects. These constitute the continuing assertions from Russian media, the judicial system, and other Federal agencies and officials that past and current members of the SOF establishment have organized to pursue interests other than those publicly declared by the state or allowed under law. This includes especially the alleged intent to punish by assassination those individuals and groups that they believe have betrayed Russia. The murky nature of these alleged activities has formed a backdrop to other problems in the special units.

With great sympathy and curiosity, Vinen unpicks the myths of the two 'gap years', which all British men who came of age between 1945 and the early 1960s had to fill with National Service. Millions of teenagers were thrown together and under often brutal conditions taught to obey orders and to fight. The luck of the draw might result in two years of boredom in some dilapidated British barracks, but it could also mean being thrown into a dangerous combat mission in a remote part of the world. By any measure National Service had a huge impact on the nature of British society, and yet it has been remarkably little written about. As the military's needs wound down and Britain ceased to be a great power, National Service came to be seen as just an embarrassment, and its culture of rank and discipline something which many British people were by the 1960s running away from. But without a proper understanding of National Service the story of post-war Britain barely makes sense. Richard Vinen provides that missing book. It will be fascinating to those who endured or even enjoyed their time in uniform, but also to anyone wishing to understand the

unique nature of post-war Britain.

The Military and Liberal Society Tomas Kucera 2017-08-25 This book describes to what extent and in what ways the military policies of Western European societies are determined by liberal ideology. A wide variety of issues affected by liberal ideology, including conscription, conscientious objection, military mission, military ethics and the professional identity of soldiers are addressed in the book. The empirical analysis draws on the cases of the German Bundeswehr (from the 1950s onwards), the Swedish Armed Forces (the transformation after the end of the Cold War), and the British Armed Forces (from the beginning of the twentieth century onwards). Contrary to the notion of antithetical societal-military relationship, this book demonstrates that a meaningful adaptation of the military to the principles possessed by its parent society can be, more often than not, desirable also from the perspective of security strategy. politics, security studies and IR.

Eyewitness Korea James Goulty 2018-11-30 Today the Korean War of 1950-1953 is overshadowed by later twentieth-century conflicts in Vietnam and the Middle East, yet at the time it was the focus of international attention. It threatened to lead to a third world war, and although fought on a limited scale, it still involved over a million men under UN command and even more on the Communist side. It left the American and British troops who took part with a range of intense recollections that often marked them for the rest of their lives, and it is these experiences that James Goulty draws on in this eyewitness history of the conflict. The Counter-insurgency Myth Andrew Mumford 2012 This book examines the complex practice of counter-insurgency warfare through the prism of British military experiences in the post-war era and endeavours to unpack their performance. During the twentieth century counter-insurgency assumed the status of one of the British military's fortes. A wealth of asymmetric

warfare experience was accumulated after the Second World War as the small wars of decolonisation offered the army of a fading imperial power many opportunities to deploy against an irregular enemy. However, this quantity of experience does not translate into quality. This book argues that the British, far from being exemplars of counter-insurgency, have in fact consistently proved to be slow learners in counter-insurgency warfare. This book presents an analysis of the most significant British counter-insurgency campaigns of the past 60 years: Malaya (1948-60), Kenya (1952-60), South Arabia (1962-67), the first decade of the Northern Irish 'Troubles' (1969-79), and the recent British counter-insurgency campaign in southern Iraq (2003-09). Colonial history is used to contextualise the contemporary performance in Iraq and undermine the commonly held confidence in British counter-insurgency. Blending historical research with critical analysis, this book seeks to establish a new paradigm through which to interpret and analyse the British approach to counter-insurgency, as well as considering the mythology of inherent British competence in the realm of irregular warfare. It will be of interest to students of counter-insurgency, military history, strategic studies, security studies, and IR in general.

The Evolution of Special Forces in Counter-terrorism J. Paul de B. Taillon 2001 The threat of terrorism knows no borders, and, given the complexities of today's

global system, no nation can afford to stand alone. This study considers the role that international cooperation plays in assisting elite military forces engaged in low intensity and counter-terrorist operations, particularly hostage rescue efforts. Using historical examples from the experiences of Great Britain and the United States, the author concludes that cooperation (ranging from shared intelligence, to forward base access, to the provision of observers) can provide significant advantages in dealing with low-intensity operations.
